JUSTIFICATION FOR DECLARATION OF SURPLUS

The Miller Millermatic 250X Welder is an older, reliable piece of equipment that is approaching the end of its useful lifespan for instructional purposes. While it remains in **good working condition** (having been consistently maintained with replacement liners every 2-3 years, last used in spring, and test-passed this fall), its age (approximately 20 years) warrants replacement with newer technology to meet modern industry standards and safety training requirements for students.

The unit has been stored in a shop environment its entire life. Declaring this asset surplus will allow the District to monetize the equipment and apply the funds toward the purchase of a contemporary replacement welder.

RECOMMENDATION FOR SALE

Based on recent market research, which indicates that used Miller 250X welders sell for up to **\$1,500** through online auction platforms (such as eBay), it is recommended that the disposal process set a **minimum bid of \$500.00** to ensure

maximum return on the sale of this equipment.

It is proposed that the welder be advertised on the school district website for two weeks beginning on **Friday, November 28th, 2025**, with the sealed bidding period closing on **Monday, December 15th, 2025, at 10:00 AM**.
